ORDER:

The Tamil Nadu Nurses and Midwives Council resolve to grant Continuance of Provisional Recognition to Bhaarath College of Nursing, Agharam Village, Selaiyur, Chennai under Bharath Institute of Higher Education and Research (Deemed to be University), Chennai to conduct the following programme for the academic year 2023-2024 subject to the following conditions:

SI. No.	Name of the programme	Continuance of Provisional Recognition (CPR) granted for the Academic year	Intake per year
1.	B.Sc.,(N)	2023-2024	100 seats

- 1. Do not admit underage & overage students.
- Admission of candidates should not exceed the number indicated in Tamil Nadu Nurses and Midwives Council Order for the year 2023-2024 and admission must be made only once a year.
- 3. Every year list of candidates admitted during the year together with their age and qualification to be uploaded in the Council's Institution Management System (I.M.S.) for the purpose of registration. Also should come to the Council for certificate verification as and when informed by this Council.
- 4. The institution should not charge any capitation fee or donation for admission of candidates except the regular tuition and special fees as laid down in the prospectus/regulations.
- 5. Failure to maintain the prescribed requirements will result in de-recognition.
- 6. The institution should submit copy of the permission order for tie-up with Rural PHC Nandhivaram & Urban PHC Zaminpallavaram for the academic year 2023-2024 along with payment receipt details to this Council within three months.

- The Council is entitled for surprise inspection without any prior notice. If the institution is found unsuitable, the recognition will stand cancelled and thereupon the Council shall not be responsible for the students admitted by the institution.
- 8. The institution shall have to abide by the guidelines/instructions/regulations Nurses and Midwives Council, Nadu issued by Tamil Government/Indian Nursing Council, New Delhi from time to time.
- 9. The institution shall have to abide by the guidelines/instructions/regulations issued by Indian Nursing Council, New Delhi with regard to availability of Teaching faculty, Clinical and Physical Facilities, Infrastructural facilities in conformity with Regulations framed under the provisions of Indian Nursing Council Act 1947.
- 10. Annual Programme processing fee for B.Sc.,(N) must be paid by 30th June every year through online mode in Council website under the link "INSTITUTION MANAGEMENT SYSTEM".
- 11. Council Prescribed Uniform should be adoned by the students and it should be strictly adhered
- 12. All the correspondence should be done by the Principal only.
- 13. Check Council's website: www.tamilnadunursingcouncil.com frequently for updates.
